BUSINESS CORPORATIONS ACT

INSTRUCTIONS

Use this form to collect information to submit to an authorized [Corporate Registry Provider](#). The information will be filed with the Registrar of Corporations in accordance with the *Business Corporations Act*.

- Item 1. Enter the full legal name of the corporation as it is now registered in the home jurisdiction.
- Item 2. Enter the Alberta corporate access number, if one has been assigned. It is printed at the top of the:
- Certificate of Registration.
 - Certificate of Assumed Name.
- Item 3. Check (a) if the corporation is adopting an assumed name for use in Alberta.
- Enter the new assumed name.

OR

- Check (b) if the corporation is changing the assumed name it uses in Alberta.
- Enter both the current and the new assumed name.

OR

- Check (c) if the corporation is cancelling its assumed name and will begin using its legal name, i.e. the corporation name in its home jurisdiction.
- Enter the assumed name that is to be cancelled.

- Item 4.
- Enter the first and last name of the authorized individual. The middle name is optional.
 - Select the appropriate relationship to the corporation.
 - Enter the telephone number of the signing authority.
 - Enter the email address of the signing authority.
 - Enter the date of submission.
 - Ensure the form is signed.

This notice must be submitted with the following:

- In the case of a **new or changed assumed name** (checkbox 3(a) or 3(b)):
 - An Alberta Corporate Name Report from the NUANS database.
 - Notification why the corporation's legal (home) name will not be used in Alberta; e.g. a letter describing the conflicting corporation name(s) in Alberta or an additional Alberta Corporate Name Report for the home name showing conflicting corporation name(s).
 - Corporate Name Reports may be omitted when a new assumed name consists of the name of the home jurisdiction, home jurisdiction registration number of the corporation, and a legal element such as 'Limited' or 'Corporation'.
- In the case of a **cancelled assumed name** (checkbox 3(c)):
 - An Alberta Corporate Name Report for the legal (home) name of the corporation.
 - Corporate Name Reports must not be dated more than 90 days before this notice is submitted for registration.
 - Corporate Name Reports may be omitted when the legal name of the corporation in the home jurisdiction has been changed to a number name assigned by the Registrar of the home jurisdiction, e.g. 33434343 Ontario Inc.

Note: The authorized representative of the corporation must present their identification to the Corporate Registry service provider in order to register this information.
