Canadian Passport	Canadian Birth Certificate	Electronic or printed and mailed utility bills for service to an Alberta address (utility, cable, home phone)
Alberta ID or Driver's License	Valid Work Permit <ul style="list-style-type: none"> - Valid for 90 days from today - Must confer temporary residence status 	Copy of a land title for a residence at which you physically reside
Out of Province/Country Driver's License	Expired Work Permit <ul style="list-style-type: none"> - Must be accompanied by letter from a lawyer, or postal receipt with applicant's name or Status Report from CIC website indicating application for new Work Permit has been submitted 	Residential lease agreement for an Alberta address with you listed as the tenant
Canadian Armed Forces ID	PR Card or Confirmation of PR	Original mailed financial statement, bill or cheque
Secure Certificate of Indian Status (SCIS)	Canadian Citizenship Certificate (issued after Feb 1, 2012) <i>or</i> Canadian Citizenship Card (prior to Feb 1, 2012)	Original mailed government statements or cheques such as AISH, Carbon Tax, GST cheque, Income Tax Assessment, Notice of Assessment, etc.
Metis Nations of Alberta Card (new version)	Valid Canadian Passport	Written confirmation from an education institution confirming you or a dependent are attending school full time
Police ID (Municipal, Provincial or Federal)	Study Permit <ul style="list-style-type: none"> - Must be valid for 90 days from today 	Written confirmation from an Alberta Hutterite Colony stating that you are a resident of the colony
Valid Foreign Passport with appropriate Immigration documents Permanent Resident Card School ID Firearm ID	Refugee Claimants can show: <ul style="list-style-type: none"> - Work Permit which confers Temporary Residence Status <i>or</i> <ul style="list-style-type: none"> - Positive Notice of Decision from CIC If unable to show the above, Motor Vehicle specialist approval from GOA is required.	Original mailed paystub within 90 days or written confirmation of Alberta employment including contact name and telephone number, current within last 15 days
<p>Note: One document may satisfy Identity and Legal Entitlement, if appropriate (for example, Passport or Permanent Resident Card). ALL documents must be original (no copies, even certified copies).</p>		Alberta Health Care mailed statement (account holder must be the same person applying for a Driver's License or ID)
